

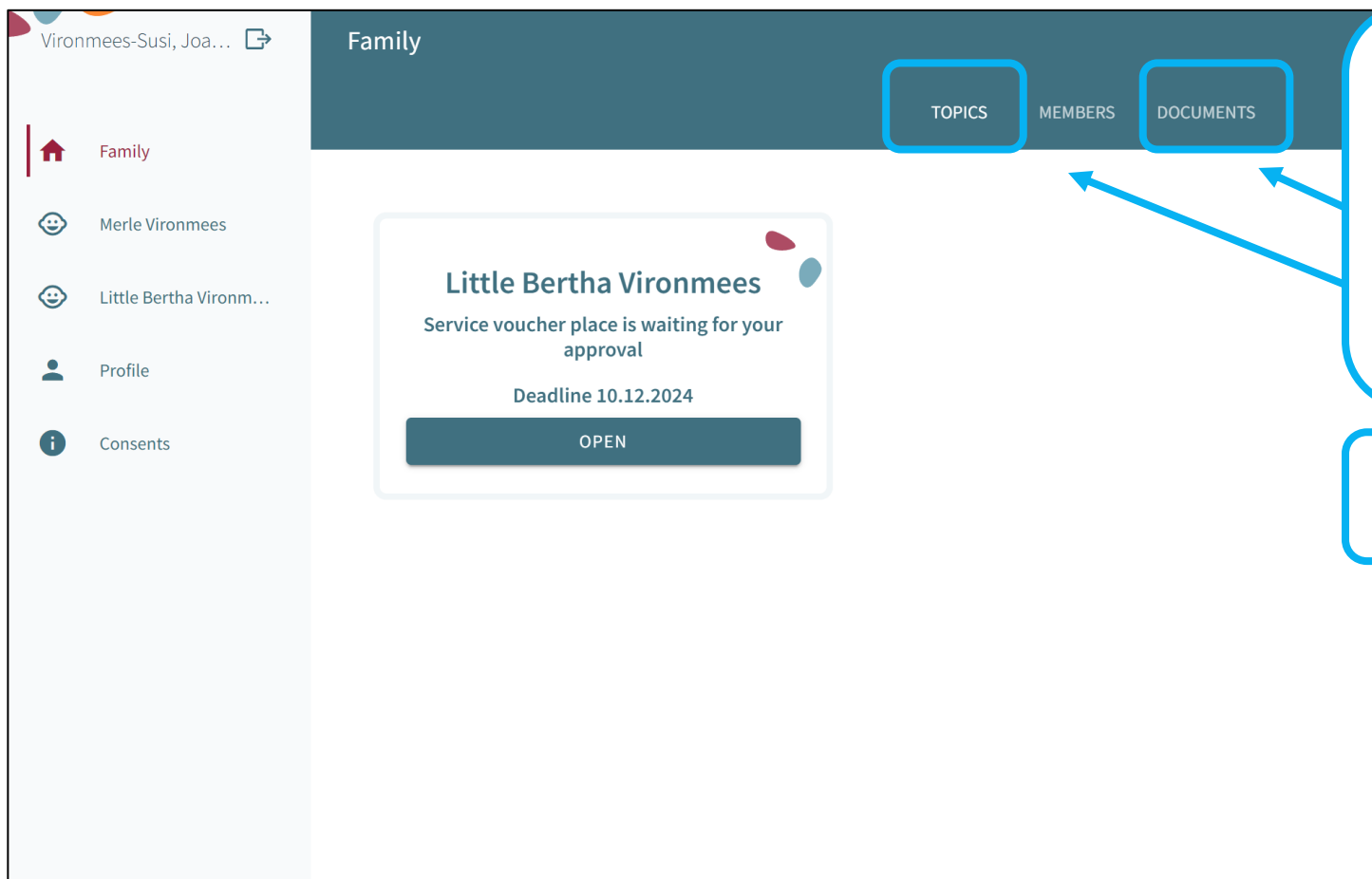
**Accept or decline

The service voucher acceptance document 1/2



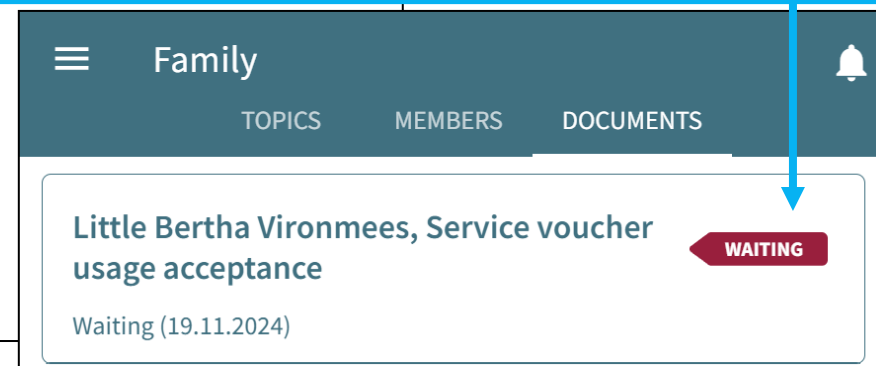
When a professional has made a positive decision on the child's service voucher, the guardian is notified about it by an email sent to the email address they notified in the communication settings of the VaSa service.



As a guardian you can access the service voucher acceptance document either through the link in the email they received or by logging in the VaSa service (vantaa.cgivesa.fi). After you have logged in you can find the the reception card on the

- Topics tab, or
- through the Documents tab.

Documents waiting for the guardians' action are marked with 'Waiting'.



The service voucher acceptance document 1/2



In the acceptance document, you can see the details of the service voucher:

- child's name
- unit on which the decision has been made
- type of early childhood education and care
- start date of early childhood education and care
- extent of early childhood education and care
- service format (private).

The service voucher acceptance card will remain on the Topics tab until the service voucher is either accepted or declined.

An early childhood education service counselor can also accept or decline the place on behalf of the guardian.

Accept or decline service voucher usage ?

Your child has been issued a service voucher. Accept or decline the service voucher by the deadline below.

Before accepting the service voucher, you should contact the private daycare center accepting the service voucher and make sure there is a place for your child. If your child's application for early childhood education has also had a public unit as an option, when declining the service voucher, you can choose whether the child would need a place at a public unit.

If you decline the issued service voucher and the child again needs to get a place in early childhood education, a new application must be made for them. The application will be processed within the time required by law.

If you cannot accept or decline the service voucher, contact the decision maker, so that they can accept or decline the place on behalf of you.

Accept or decline service voucher usage ?

You can accept or decline the offered service voucher by the deadline. You will receive a reminder email if you have not accepted or declined the service voucher as the deadline approaches.

An early childhood education service counselor can also accept or decline the place on behalf of the guardian also after the deadline has passed.

If you open the acceptance document that has been accepted and the child has not yet begun attending early childhood education and care, you can still decline the place if the deadline of the acceptance document has not been surpassed.

Accepting or declining the service voucher usage 2/4



You can either accept or decline the service voucher place.

Under the 'Decline the service voucher place' selection there are two alternatives, if the application has stated at least one wish for a municipal early childhood education place:

- Decline service voucher, but the child needs a place from public early childhood education and care.
- Decline service voucher, because the child doesn't need a place from early childhood education and care.

- the comment added by the professional under 'Additional information', as well as
- any attachment, if provided.
