DELIVERING THE DECISION

I consent to having the decision on the child's after-school activities in electronic format, so that the decision can be viewed on Wilma, on the Applications and decisions tab. The decision does not have to be separately mailed to me.

I pledge to familiarize myself with the decision on Wilma, after it has been published. I understand that the appeal period ends on the 14th day from the day of receiving the notification. In this kind of electronic notification, the day of notification is the third day from the day the decision was published.

Morning activities in Vantaa are only organized at a few operating units. We are now surveying the demand for morning activities in Vantaa. In some cases the place for morning activities could be different from that for after-school activities. If morning activities were organized in your area, would your child participate in them? A separate fee will be charged for morning activities, specified by the organizer.
