

AGREEMENT ON THE USE OF EARLY CHILDHOOD EDUCATION AND CARE

Making the agreement



- Agreement on the use of early childhood education and care agrees on the use of the weekly hours granted based on the child's early childhood education and care, pre-primary education, instruction preparing for basic education as well as complementing early childhood education and care decision.
- A new agreement will be made with the educator of the child's group or with the daycare centre manager when:
 - the child begins attending a new daycare centre or a new group
 - the child's early childhood education and care hours change
 - a new early childhood education and care decision is made for the child.
- The educator or the daycare centre manager enters the contractual data onto the VaSa service. You can browse the agreement on the Documents tab.
- After entering the document, the educator will send it to you for approval. When you have approved of the agreement, also the daycare centre manager will approve it.

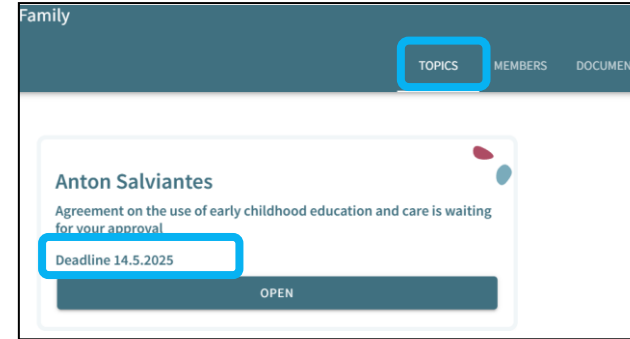
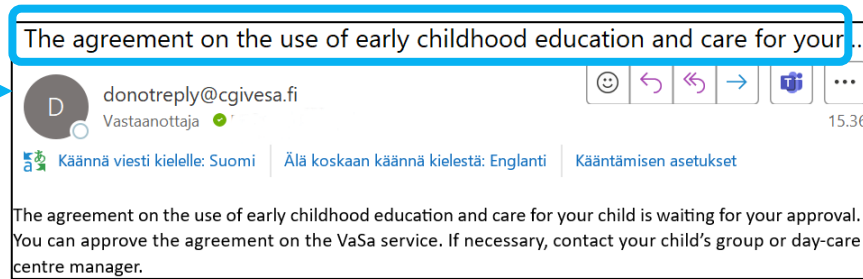

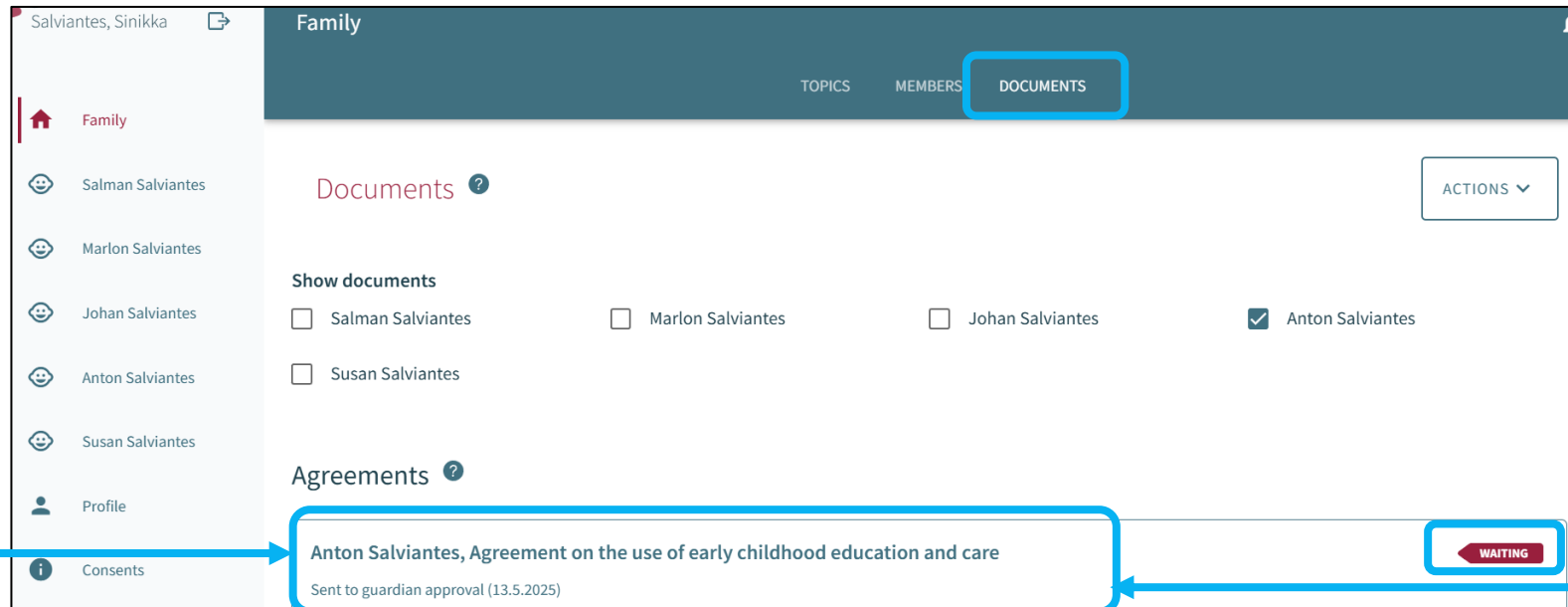

The Agreement on the use of early childhood education and care part shows you the basic information of the agreement.

- Dates of starting and ending
- Child's name and date of birth
- Decision: Type and date of the child's decision
- Unit: Child's daycare centre or family day care place
- Extent: Early childhood education and care hours granted to the child
- ECEC Usage: Use of early childhood education and care; daily or part week

Approving the agreement 2/4



The Contracting parties part shows you

- Participating guardians: The guardians participating in making the agreement
- Approving guardian: The guardian that was chosen as the guardian that approves the agreement when making the agreement.
- Participating professional: The professional that filled out and sent the agreement to the guardian's approval.
- Approving professional: The daycare centre manager that approves the agreement after the guardian has approved it.

The Planned ECEC times part shows you either Regular ECEC times or Irregular ECEC times, or both, depending on what has been agreed in the agreement.

- Regular ECEC times part shows you the agreed clock times per days of the week.
- Irregular ECEC times part shows a note stating that the hours will be announced later in the attendance plan according to the facility's instructions.
