#### **INSTRUCTIONS**

This application form applies for taxi transportation

- · for a child in early childhood education
- for a child in pre-primary education or in preparatory instruction and in early childhood education supplementing it.

If the child is in pre-primary education or in preparatory instruction and does not need early childhood education, apply for transportation to pre-primary education or preparatory instruction on the form Application for granting accompanying benefit / taxi transportation for special reasons for a student in pre-primary education / preparatory instruction (form number 523086a).

Grounds for granting transportation (Education and Learning Committee, May 16, 2023, §12)

When arranging transportation for children in early childhood education, the following grounds are applied:

- The transportation can be arranged for a child needing developmental and learning support, who
  benefits from participating in early childhood education, and whose guardian is justifiably unable
  to transport the child to the early childhood education place designated.
- 2. The transportation decision is primarily made for one direction to ensure contacts between guardians and early childhood education.
- 3. Granting the transportation is discretionary. When assessing the need for transportation and deciding on it, the following will be accounted for:
  - a. the length of the child's travel to the early childhood education place designated to the child from the child's home exceeds two (2) kilometers;
  - b. there is no reasonable public transport connection to the early childhood
  - c. the guardians are unable to transport the child or accompany the child;
  - d. the child has an expert report recommending the transportation; or
  - e. the family's overall situation does not reasonably allow for transporting the child.

The decision on the child's transportation for special reasons will be delivered to the child's address. The transportation data, as well as the guardians' contact information, will be disclosed to the company in charge of the taxi transportation. Due to the preparations related to arranging the transportation, the transportation can begin, at the earliest, three weeks after the decision was made.

In case there are any changes in the child's circumstances — e.g., the address of the home or of the early childhood education place changes — a new transportation application shall be submitted to the director of the child's early childhood education place, so that the situation can be reassessed.

Transportation is always granted for a temporary period, and the need for it will be checked in case of changes in the situation or, at minimum, once a year.

The data of the application will be entered into Vantaa Education and Learning department's customer register.
