INSTRUCTIONS FOR FILLING IN THE APPLICATION

Use the attached enrollment form to enroll your child in pre-primary education. The information is registered into a customer information system (VaSa), maintained by the City of Vantaa.

1. Child's personal data

The identity number shall be complete. Language spoken with the child at home.

4. Child's day care in addition to pre-primary education

If the child has not been in day care in Vantaa during the operating year preceding pre-primary education and if he or she needs day care in addition to pre-primary education, apply for day care on the day-care application form.

In case of a child already in day care and who continues to need day care in addition to pre-primary education, fill in and return the day-care income statement form and appendices that will be mailed to your home address during the spring.

5. Desired pre-primary education place
