

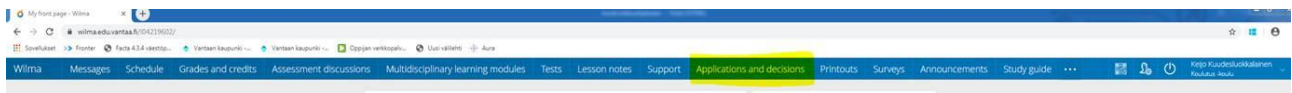
INSTRUCTIONS FOR GUARDIANS FOR COMPILING A WORK-BASED BASIC EDUCATION (TEPPO) APPLICATION

INSTRUCTIONS: Guardian makes a TEPPPO application on Wilma

Electronic application forms for school's TEPPPO activities can be submitted through Wilma from January 7 through March 15, 2026. The school's own 7th—8th-graders can apply for TEPPPO activities. The Wilma application shall be filled in with the guardian's identifier. We recommend that guardians fill in the form together with their child. The guardian can edit the application during the application period up to March 17, 2026.

Instructions for filling in the application form on Wilma:

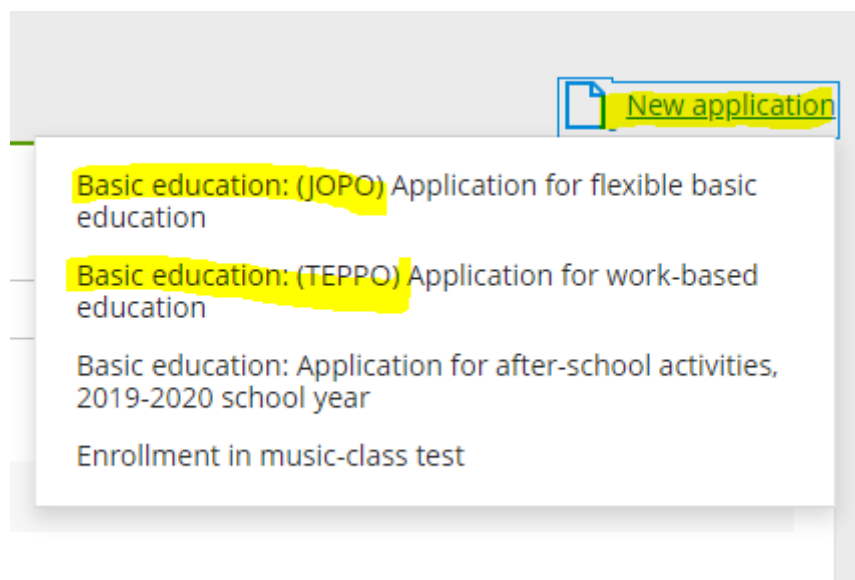
1. Chose **Applications and decisions** at the top bar



2. At the top right is **New application**



3. choose under it **Basic education: Application for work-based basic education (TEPPO)**



4. Application data

At the beginning of the application is a link to a web site where you will find more information on TEPPPO studies and on the criteria for choosing TEPPPO students.

Student's name, identity number and class data will be automatically updated on the form.

Guardian's name, address and phone data will be updated from the population register, and they cannot be edited.

Into the **Grounds for application** field, the guardian and student shall together enter the grounds for applying for work-based basic education. The field is obligatory.

The **pedagogical documents** part includes information on a potential pedagogical assessment or account made for the student.

Both guardians' consent to making a TEPPPO application is ensured by asking them to tick the box "Student's both guardians give their consent to the student's application for work-based basic education."

Students and their guardians, who apply for TEPPPO, will be interviewed at school. If your family needs an interpreter in TEPPPO interview, please tick box "Our family needs an interpreter in TEPPPO interview" and write language to "language of interpretation".

Consent to not having the TEPPPO decision mailed to the guardians in May is ensured by asking them to tick the box "I give my consent to electronically informing me about the decision on work-based basic education for my dependent so that the decision can be viewed on Wilma on the "Applications and decisions" tab on May 8, 2026. The decision does not have to be separately mailed to me."

The **Application date** and **Filled out by** fields are obligatory.

Finally, press the **Save data** button. You will receive a confirmation that the application has been received.
