Return the form immediately after fulfillment of the employment condition as an encrypted email message to: tyonantajapalvelut@vantaa.fi. When filling in the training agreement place, you do not have to fill in the field: "Duration of unemployment."

The personal data disclosed in the notification will be kept for 15 months, after which they will be deleted. Before deleting the data, the people in question may be contacted in connection with follow-up monitoring. The follow-up monitoring will not cause any measures to be taken by the person in question. Personal data will not be disclosed to parties outside Employment Services. The data disclosed in the notification that do not constitute identifiable personal data may be saved and used for planning and arranging operations and services, as well as for statistics for as long as necessary.
